HOLIDAY INSURANCE

YOU ARE STRONGLY ADVISED TO OBTAIN HOLIDAY INSURANCE TO COVER THE COST OF YOUR HOLIDAY AND OTHER ASSOCIATED EXPENSES.

CANCELLATION - ALTERATIONS

Cancellations are to be in writing by the person who made the booking.

The following cancellation charges will be applied:

Cancellation within the preceding period of the holiday date	Cancellation Fee

20 weeks	75%
26 weeks or more	25%

GUESTS RESPONSIBILITIES

The Security/Damage Deposit is payable when paying the final payment. It is used to cover the cost of any damage, breakages, cleanliness etc. The cottage is to be left in a clean and tidy condition on departure, and the deposit will be returned within fourteen (14) days after the end of the holiday, less any deductions for damage, breakages or for any excessive cleaning we carried out etc.

The use of the accommodation, equipment, swimming pool and any other amenities on site, is entirely at the hirer's risk and no responsibility can be accepted for injury, loss or damage to the guests personally, or their belongings - including cars.

Only persons named on the Booking Form are entitled to stay at Maison de la Famille and enjoy the use of its facilities and equipment. No other persons will be allowed access.

PLEASE NOTE In common with most of rural France, we are serviced by a septic tank. It is important that no sanitary or baby items are flushed down the toilets and only French toilet paper may be used (English loo paper is apparently indigestible to the septic tank flora!) Only toilet cleaners suitable for septic tanks may be used. However, we do supply an initial quantity of toilet tissue and cleaner which will be at the cottage for you.

No glass or china is to be taken to or used in the pool area. Should any fall into the pool, we'd need to empty, clean and re-fill the pool. This can take a number of days, which could spoil the holiday for the other guests as well as your own. You may also lose your Security/Damage Deposit as a result.

OWNERS' LIABILITIES

The Owners shall not be liable to the guests for any temporary defect or stoppage in the supply of Public Services, nor in respect of any equipment, machinery or appliance in the cottage, garden or swimming pool; nor for any loss, damage or injury caused by adverse weather conditions, riot, war, strikes of any other matters beyond the control of the Owners; nor for any loss, damage or inconvenience caused to or suffered by the Guest should the property be destroyed or substantially damaged before the start of the rental period and in any such event the Owner shall within seven (7) days of notification to the Guest, refund all sums previously paid by that guest in respect of the holiday period.

Under no circumstances shall the Owner's liability to the Hirer exceed the amount paid to the Owner for the rental period.
